Our annual meeting was held recently on Mar 23, 2023, as is required by our bylaws.

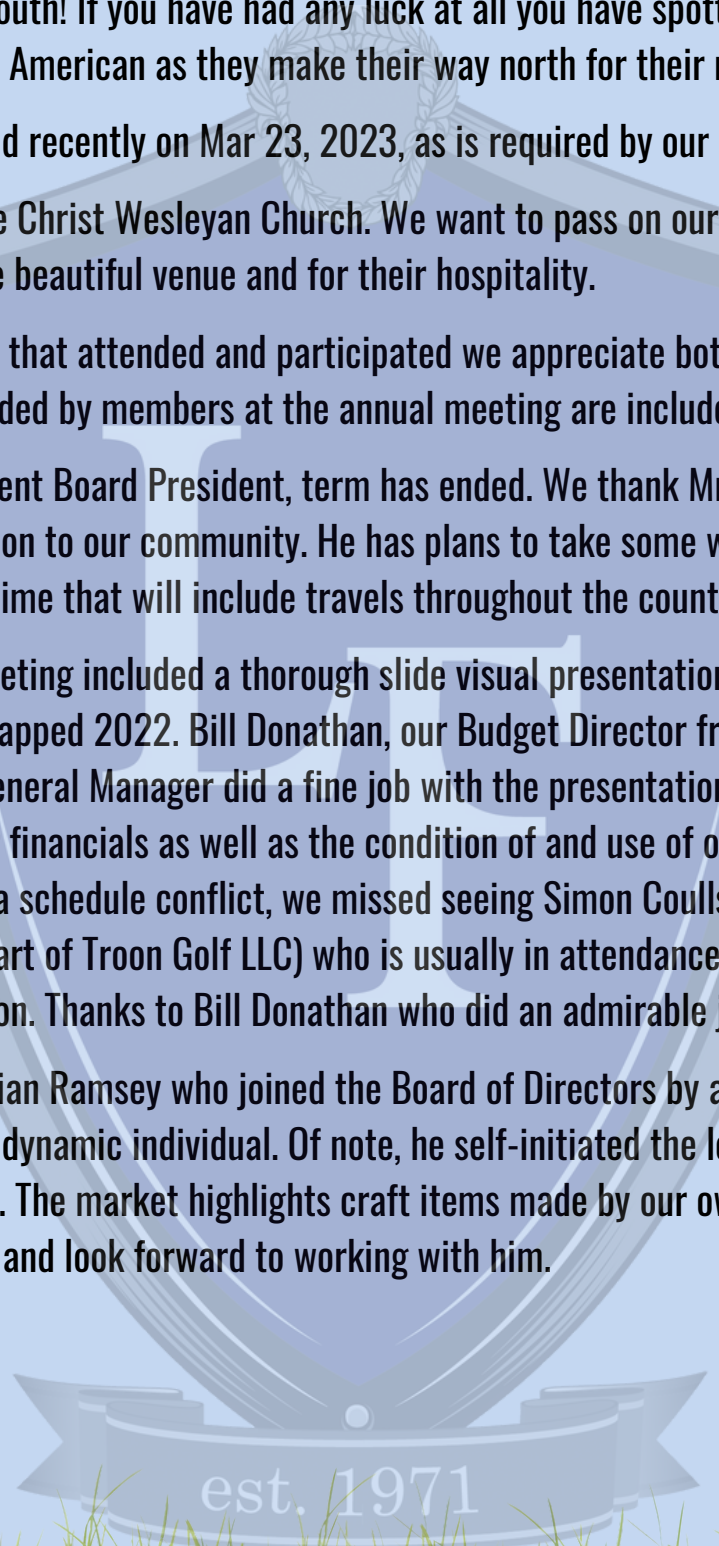
The meeting was held at the Christ Wesleyan Church. We want to pass on our thanks to the Church staff and Pastor for providing the beautiful venue and for their hospitality.

Members of our association that attended and participated we appreciate both your time and input. Answers to questions provided by members at the annual meeting are included with this newsletter.

Mr. John Lake, our most recent Board President, term has ended. We thank Mr. Lake for his 7 plus years of service and for his devotion to our community. He has plans to take some well-deserved time off and enjoy some personal down time that will include travels throughout the country with his lovely wife.

Highlights of the annual meeting included a thorough slide visual presentation remade by our Management Team that recapped 2022. Bill Donathan, our Budget Director from ICON Management and Brian Barker, our on-site General Manager did a fine job with the presentation and review. Items covered at the meeting included our financials as well as the condition of and use of our Amenities (pools, golf, tennis and stables). Due to a schedule conflict, we missed seeing Simon Coulls, Senior Vice President from ICON Management, (part of Troon Golf LLC) who is usually in attendance for this meeting. We look forward to seeing Simon soon. Thanks to Bill Donathan who did an admirable job in Simon's absence.

Finally, we welcome Dr. Byrian Ramsey who joined the Board of Directors by acclamation. He is highly skilled in many areas and a dynamic individual. Of note, he self-initiated the local "Lake Forest Market" that is held once per month. The market highlights craft items made by our own community members. We welcome Byrian aboard and look forward to working with him.





Notes from the Board of Directors contd.

Questions / Answers From Annual Meeting:

Question 1: How was a board position filled?

The vacant board position was filled by acclamation. An election for the open seat was not necessary as there was only one qualified candidate for this election cycle, Dr. Ramsey. Therefore, he becomes a board member after the annual meeting. Presently, there is one open board position.

Question 2: Why does the Board have legal counsel?

As a private-non-profit 503-C7 organization, the LFPOA Board, from time to time, needs legal expertise that may not be able to be provided by our in-place Board Attorney. When this occurs, guidance from another Attorney may be sought. When this occurs, guidance from another Attorney may be sought. Recoupment of legal costs is common. Legal actions are discussed in executive sessions and once concluded, generally can be published.

The community of Lake Forest is a restricted covenant community and has been since incorporation in 1971. Without the POA there would no ARC enforcement or amenities which would lead to loss of property values.

Question 4: Golf Charges; why don't we charge members for golf?

Members in good standing can play our course for "free" as part of the membership. However, there is a cart fee that all must pay. Non-members and non-residents pay greens and cart fees to play our course. All golf rates are reviewed annually and are set as part of budget review and management recommendations.

Question 5: Why were operations at the Yacht Club changed?

A shift in Yacht Club Operations to a new management team was entered into recently due to many years of sustained operational losses. The transition to the new operators is completed, and they are expected to reopen this Spring.

Question 6: Why do we have covenant enforcement?

We are a community that is founded by our deed covenant-restricted community documents. As such, enforcement of our covenants is part of the duties and responsibility of the POA. Therefore, parking in front yards, work trailers in front yards, RV's in front yards, boats in front yards, and placing garbage curb side too early in advance of scheduled pick-up dates are examples of areas of ARC enforcement that could include fines if not remedied.

Question 7: Why are property lines challenged?

At times, conflicts arise between homeowner property lines. This civil matter between homeowners may require a private survey to remedy. When an encroachment occurs onto LFPOA property, such as onto the golf course, a survey may also be required as a step to remedy.





Notes from the Board of Directors contd.

Question 8: What do our dues pay for?

Generally, the current dues rate of \$60 allows us to pay for our staff, ARC covenant enforcement, and for the care, upkeep, insurance, and any necessary repairs or improvements to our amenities. The dues rate was able to remain at \$60 for this year in large part to the new operating agreement we have in place for Yacht Club. If the dues rate remains stagnant the common property and amenities will fall into disrepair.

Question 9: What is the current financial status of the POA and IRS Audit?

We completed a comprehensive Audit by the IRS in October of 2022. The IRS Audit was completed with no findings, and found our organization to be compliant with all IRS rules. The IRS Audit found no embezzlement, misuse of funds, or kickbacks as had been alleged.

We are currently undergoing an additional scheduled Third-Party Audit for our 2022 financials. We have a standing Third Party Review done by a Third Party annually. These reviews have also had no significant findings.

Our financials are posted on our website each month.

The POA is financially solvent. We have no debt. We have a reserve fund and a building fund. All capital projects for our pools and Yacht Club were done without debt. Completing the Yacht Club project has enabled a new operating agreement.

Question 10: Can we get additional security?

As part of Daphne, we are provided security from Daphne Police. Occasionally, we have added security safety monitors for our pools. We could certainly look into adding private security measures in addition to Daphne Police Department. The cost to do so is a consideration.

Question 11: Speeding in Lake Forest is a problem?

The speed limit in all neighborhoods in Daphne is 25 MPH unless posted otherwise. Enforcement is done by Daphne Police.

Question 12: Short-Term Rentals; why is this a problem?

AIRBNB, VRBO, and other short-term rental groups and rental owners are increasing this activity in Lake Forest. We are zoned R-3, which is a single family home residential area within Daphne. In general, rental homes in Lake Forest are more prone to have ARC violations, especially parking in yards and trash placed curbside to early in advance of scheduled pickup days. Short term rentals promote a high turnover rate than if a full-time resident or by a long term renter occupied the home. All rental units in Lake Forest are required to register at the office, and a point of contact must be provided. Use of our amenities is for the property owner's enjoyment and not for a transient resident, which short term rentals become. This issue is being studied, and possible future changes to our house and grounds may be considered.

Pool Rules

POOL CARD INFORMATION

You will need a magnetic pool card to access pools. To get your magnetic pool card please go to the Lake Forest office to fill out a form and pay just \$5. The magnetic pool card is good at all 3 pools. Please enjoy and obey our pool rules for your safety and your fellow neighbors.

- Pool is available to all Member/Residents in good standing with LFPOA
- Sharing of Pool Pass Entry Cards with the general public or with member not in good standing is not allowed and could lead to loss of pool privileges
- Members in good standing can invite up to 4 total guests per day
- Tampering with the Access Gate is not authorized
- Damage to any property or grounds could lead to suspension from use
- No one under the age of 16 allowed without adult supervision
- All bathers must shower before entering pool
- No alcoholic beverages, glass or food allowed
- No tobacco products-this includes cigarettes, cigars, and chewing tobacco
- No e cigarettes or vaping allowed
- No running, horseplay or rude behavior allowed
- No diving
- Be courteous to your neighbor
- Pets are not allowed in pool area
- Do not enter the pool if you have communicable disease, an open cut or ill with diarrhea



Violation of any Rules could lead to suspension or loss of Pool Use Privileges

Inclement Weather Policy

All swimmers must exit pool during thunderstorms.
Pool will reopen 30 minutes after lightning strikes cease.

Pool Closing

Discharge of fecal matter will cause the pool to close immediately. Swim diapers must be worn by bathers that are incontinent or lack toilet training.

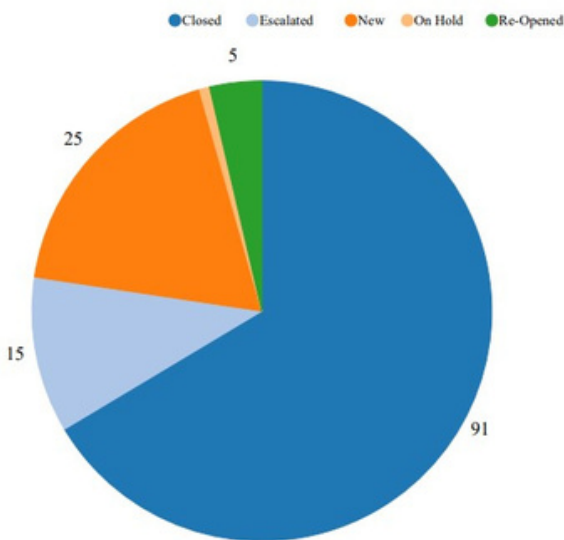

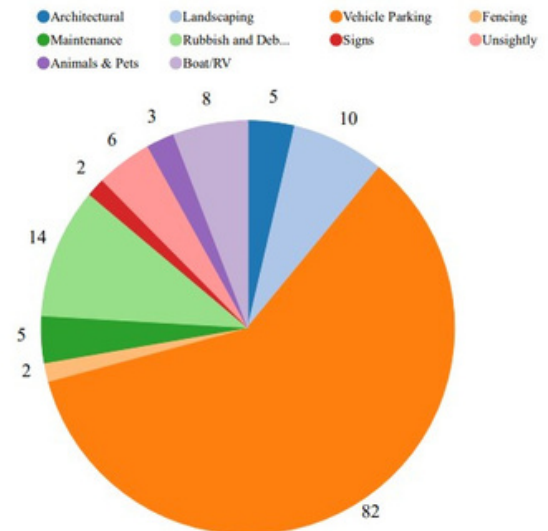

News from our State House Representative Matt Simpson

As April begins, I am pleased to begin by saying that I am humbled that the Alabama House of Representatives passed HB1, the bill I created to mandate prison time for criminals trafficking the deadly drug fentanyl, passed unanimously in the House a few weeks ago. All 105 members of the House voted in favor of the bill, which I have been told is the first time that has happened in more than 30 years.



This shows you that the fentanyl epidemic is not a partisan issue; it is affecting everyone in every community, regardless of race, religion, creed or gender, and I am so glad to see all of my House colleagues join together to send a message to these dealers of death that we are not going to stand back and let them keep killing people.

That bill now heads to the Senate, where I am hopeful we will see it swiftly passed and sent onward to Gov. Ivey's desk for signing. I am thankful that Gov. Ivey has made the bill a legislative priority she mentioned in her State of the State Address and that she supports getting this bill across the finish line as soon as possible to protect our people.

Another bill passed the same day as HB1 and in a similar fashion, HB101 from Rep. Ginny Shaver (R – Leesburg) that will help streamline the adoption process in our state and make it easier for parents who want to adopt and add to their families.

Rep. Shaver is a former crisis pregnancy counselor, so she understands firsthand how difficult that process has been for families across our state. Her bill takes the current adoption laws for our state and splits them up between adopting a child and adopting an adult, which is a change necessary because of the inherent differences between the two types of adoption.





News from our State House Representative Contd Matt Simpson

I would also like to let you know that House Speaker Pro Tem Chris Pringle, from our sister delegation in Mobile County, had some good news this past week with his HB82, which would allow drug dealers to be charged with manslaughter if the drug they sold results in someone’s death. I don’t think there are many people that would be against this bill and I am so glad he has continued to fight for this bill – especially because he created this legislation after the death of the son of a family friend who was sold oxycodone laced with fentanyl.

I am hopeful that his bill and my bill will both soon be on Gov. Ivey’s desk for her signature and that they will then become law that will help to begin making this state a safer place with these dealers of death knowing that they will be seeing jail time for their crimes instead of being able to use their dirty drug money to bail themselves out immediately after sentencing.

At the local level, your delegation members have all been working hard to represent their districts and Baldwin County as a whole, and I believe when we return to Montgomery this month, you’ll see a number of local bills hit the hopper and be discussed in our Baldwin County House Committee – which I will likely be discussing with you next month.

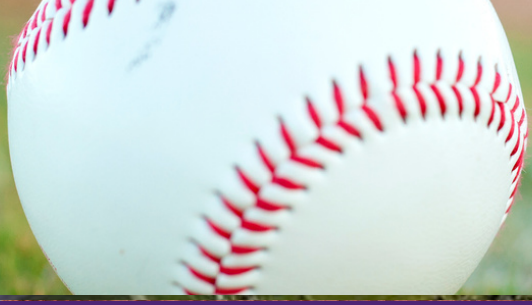

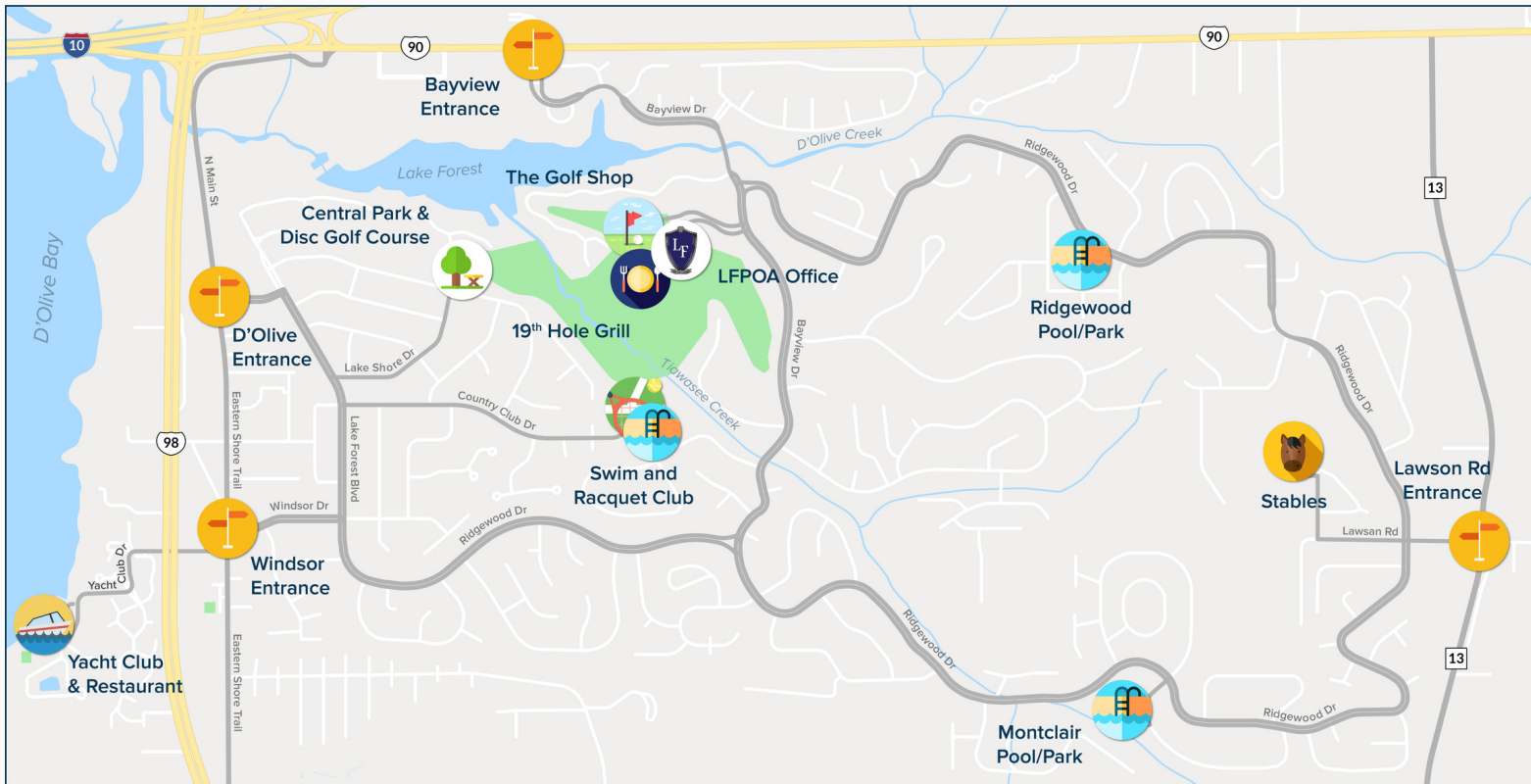
