Looking for a Place to Enjoy a Nature Walk?

Over the last several years the POA has achieved small incremental improvements to our power easement in order better maintain the area and also to facilitate a "Greenway" Walking Path for our community.

The Grass Walking Trail is patterned after a Trail System that can be found in Amelia Island Florida.

The improvements make the area easy to maintain and less susceptible to storm water runoff.

The passive walking trail is nearly 8 ft wide and stretches over 3,900 feet in length, nearly 3/4 quarters of a mile.

When used in combination with existing median sidewalks on Ridgewood helps to expand our recreational and exercise trail opportunities to several miles.

There are several access points located near the intersection of Lawson Road at Ridgewood Drive as well as just south of Ridgewood Pool on Ridgewood Drive.

Use of the trail like our median sidewalk is intended for walkers, joggers, and bikers.

The trail is not intended to be used by four wheelers, motorcycles, and any other vehicles and their operators. While using the trail please have awareness for those also enjoying our golf course.

Many thanks to our Lake Forest Golf Course Superintendent Jake Maske that made this area safer, more stabilized to prevent erosion and got this area improved for our members to enjoy.

So, if you are looking for a different and unique place to walk, our Greenway Trail is open for use.

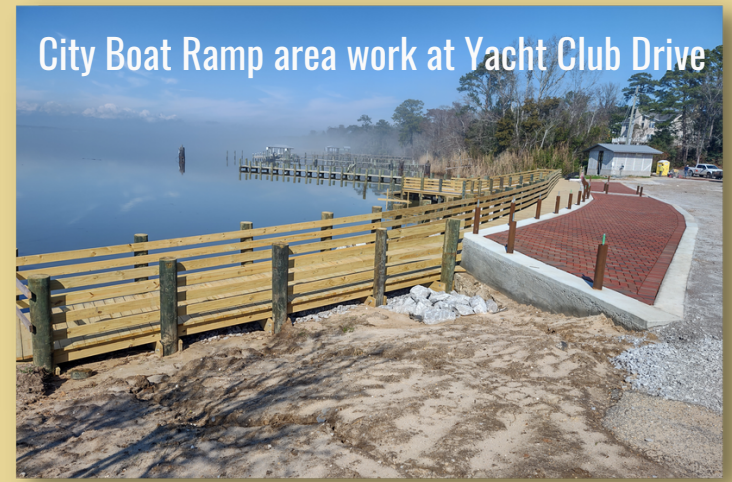
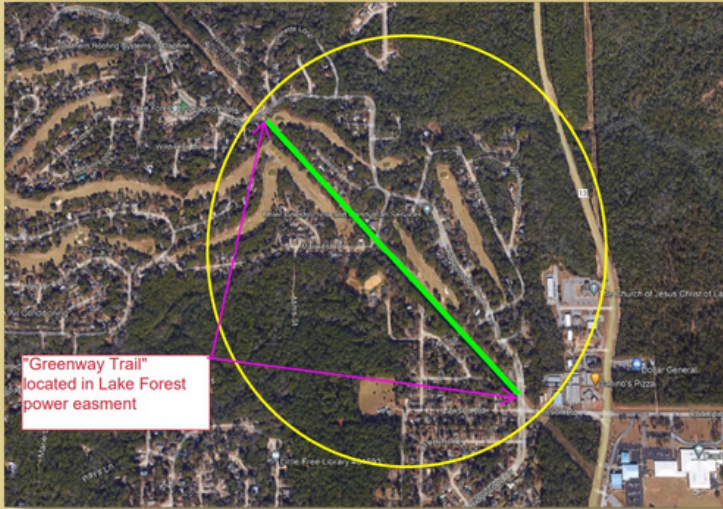
INFORMATION FOR KEY ITEMS FROM OUR LAST MEETING

- Annual Meeting will be Thursday 23 March 2023 at 7pm.
- Planned and approved Third Party Audit Underway for the 2021 financials
- Our waterfront restaurant (the Lake Forest Yacht Club) venue DBA the "Back Deck" has been reclassified as the "Lake Forest Yacht" Club for internal accounting purposes
- The Lake Forest Yacht Club currently closed for the transition phase to our new operating partners to be concluded.
- Once the transition phase is ended the venue will re-open as "The Waterfront" by our new operators Pete Blohme and Nick Dimario sometime this Spring
- Funding requests were approved to remove several derelict and abandoned boats from the dry storage area at the marina as well as to install Library Boxes at our pool locations
- Library boxes will be for a free exchange for books for use by our community.
- Lake Forest Pools will reopen weather dependent for Spring Break on or about the last week of March
- Check with the office to get your updated pool pass proxy card
- Check Fraud was attempted and has been resolved against our Lake Forest Bank Account; there was no loss of POA funds thanks to the quick action by staff and by our banking institution. The matter is being pursued by law enforcement. No Lake Forest member information or banking information was compromised.
- Lake Forest Swim Team Contract was finalized for 2023 for the use of Swim and Racket Pool for training and swim meets

The board would like to respond to comments and questions by residents who attended our meetings this past year. Many questions have been answered time and time again but some residents have never heard the following comments and answers to questions.

There are anti-Lake Forest POA websites and social media pages. The comments often rail against the Board with misinformation, half-truths, and the like. Our board members past and present have tried to provide some context and answers to issues on one of the many anti-Lake Forest websites. We were told by the website administrator, "This is an anti-board website. We are not interested in your views." The site administrators ban board members from joining these websites or for daring to provide any information or clarification. Why?...

These websites and their administrators often present themselves as philanthropic groups when recruiting members without divulging their anti-Lake Forest POA views. Why?... Why do the members with the most questions ban the board from their anti-Lake Forest POA social media sites when we try to provide answers? Simply put, They don't want "You" to hear our answers or provide context.

Over the next few digital newsletters we will publish some information to Lake Forest homeowners, who like most, want our neighborhood to be a good place to live with great amenities for the children and families to enjoy.

Special Elections: Some want a special election. We are aware.

As far as we know, Lake Forest has never had a special election in spite of multiple board members resigning over a few months period of time in the past. It isn't done by other POAs. It isn't done at the city level. When a councilman resigns a replacement is appointed. The same happens at the state level. Even when a U.S. Senator resigns, the governor of the state appoints a replacement. Appointments to open seats on our board were made legally and in accordance with our written guidance. Appointments were made from a pool of candidates that submitted their names and information for consideration. Our current board has (6) six members with (1) one vacancy.

Election for 2023 Information: There are two (2) planned board openings occurring in March due to expiration of terms. In accordance with our bylaws potential candidates had until 31 December 2022 to place their name for consideration along with other required information. There were two (2) candidates that submitted their names for consideration. Candidates are currently being vetted for qualification by the election committee. Since there were only two (2) candidates that applied for the two (2) open board seats the considerable cost of preparing and mailing election materials would serve no purpose. Candidate's vetted as qualified by the election committee would be recommended to join the POA Board.

City Liaison Update

- City of Daphne is currently planning additional sidewalks city-wide to be installed over the next several years.
- In 2023, the next sidewalk segment being planned for Lake Forest by the city is to be installed on Ridgewood Drive between Montclair Pool and the intersection with Bayview Drive. May need to be done in two phases due to escalating costs and topography challenges.
- Lakeshore Drive road repairs and drainage project is in progress and completion schedule was delayed due to scope of work changes.
- Marina Boat Area Parking Improvements and Kayak Launch is nearly completed by the City of Daphne.
- Decorative Street Signs for Lake Forest will need additional three phases to complete all of our backroads and loops; 7 phases have been completed with all thoroughfares Ridgewood Drive, Bayview drive and Lake Forest Blvd completed.
- City of Daphne is considering feasibility for other roadway improvements to aid with commuting in and around Daphne. Traffic area just south of the intersection of Highway 64 and Highway 98 is being improved near Target and Daphne Police Station known as Lavendar Lane. Other roads are being planned and considered for improvements.
- Recreationally, the city has approved the addition of another 6 pickleball courts at lot park.

Pool Rules

POOL CARD INFORMATION

You will need a magnetic pool card to access pools. To get your magnetic pool card please go to the Lake Forest office to fill out a form and pay just \$5. The magnetic pool card is good at all 3 pools. Please enjoy and obey our pool rules for your safety and your fellow neighbors.

- Pool is available to all Member/Residents in good standing with LFPOA
- Sharing of Pool Pass Entry Cards with the general public or with member not in good standing is not allowed and could lead to loss of pool privileges
- Members in good standing can invite up to 4 total guests per day
- Tampering with the Access Gate is not authorized
- Damage to any property or grounds could lead to suspension from use
- No one under the age of 16 allowed without adult supervision
- All bathers must shower before entering pool
- No alcoholic beverages, glass or food allowed
- No tobacco products-this includes cigarettes, cigars, and chewing tobacco
- No e cigarettes or vaping allowed
- No running, horseplay or rude behavior allowed
- No diving
- Be courteous to your neighbor
- Pets are not allowed in pool area
- Do not enter the pool if you have communicable disease, an open cut or ill with diarrhea

Violation of any Rules could lead to suspension or loss of Pool Use Privileges

Inclement Weather Policy

All swimmers must exit pool during thunderstorms.
Pool will reopen 30 minutes after lightning strikes cease.

Pool Closing

Discharge of fecal matter will cause the pool to close immediately. Swim diapers must be worn by bathers that are incontinent or lack toilet training.

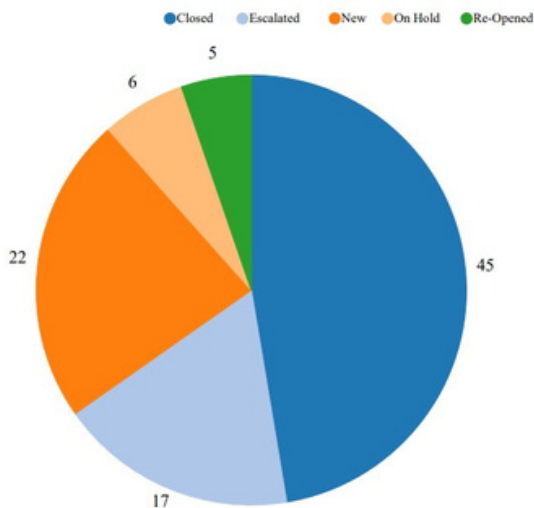

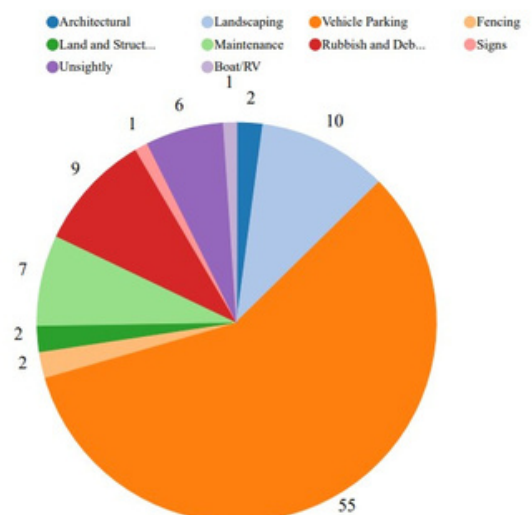

News from our State House Representative Matt Simpson

Your Baldwin County Legislative Delegation is already hard at work even before the 2023 Legislative Session officially kicks off in March.

Just a few short weeks ago, both chambers of the Legislature held their organizational sessions to elect officers and solidify committee assignments, and I am proud to say that Baldwin County will be well represented across its committees by all of its members, returning and freshmen, as our delegation members received some excellent assignments that will be beneficial to all of our constituents here in Baldwin County.



In the House, we will have two members who will have the honor as serving as Committee Chairmen – Rep. Alan Baker, who will return as the Chairman of the Local Legislation Committee (every piece of local legislation for any county that does not have a legislative delegation like ours does has to go through this committee, so this is a big deal), and yours truly, who will serve as the Chairman of the Ethics and Campaign Finance Committee (if it has to do with campaign finance, accountability, transparency and good governance, that committee will have oversight with it and I am humbled to get to Chair such a vital committee).

We also have three Vice Chairmen in our delegation that will be a big boon to Baldwin County – Rep. Baker will be our Education Policy Committee Vice Chairman, and given his years spent teaching and coaching in our public schools, he is certainly the right choice to be helping guide our classrooms and our teachers across this state. Rep. Shane Stringer, one of our new to Baldwin County members, will be Vice Chair of the Public Safety and Homeland Security Committee – with his background in law enforcement, I know his expertise and on-the-job experience will be vital in that role. And our other new to Baldwin House member Rep. Brett Easterbrook will serve as the Vice Chair of the Insurance Committee – using his common-sense conservatism and decades of experience in the construction industry to help fight the good fight on something so important as insurance is to all of us down here.

And our three brand new legislators certainly made a splash in their official Montgomery debuts and walked away with some great committee assignments to be able to work hard for our folks here.

Rep. Jennifer Fidler will serve on the Public Safety and Homeland Security Committee, the County and Municipal Government Committee (given her years of work experience with the City of Fairhope and Baldwin County, this was a great fit for her knowledge base), Urban and Rural Development and Local Legislation.

Rep. Donna Givens will be putting her years of experience with Baldwin EMC to use on the Transportation, Utilities and Infrastructure Committee, as well as the Boards, Agencies and Commissions Committee (overseeing the boards and agencies that can impact so much of this state), Local Legislation and the newly created Ports, Waterways and Intermodal Transit Committee, chaired by our Mobile County Delegation friend and Baldwin County native Chip Brown.

Given our location in this state, I don't think I have to tell you how important that Ports and Waterways Committee will be, so I'm glad Rep. Givens, Rep. Stringer and I will all be serving on it together.

And, last on our House list, but certainly not least – Rep. Frances Holk-Jones will represent Baldwin County on the always important Health Committee, the Education Policy Committee and she will bring her life experience and know-how to its fullest bloom in the Economic Development and Tourism Committee, where I know she will represent her district incredibly well – when you think of Alabama Tourism, her district should be the first place we all think of and I know she will knock this out of the park.

Rounding out the rest of our committee assignments: Rep. Baker will also serve on the Ways and Means Education Trust Fund Committee; Rep. Easterbrook will serve on Agriculture and Forestry as well as the Transportation Committee; Rep. Stringer will have a seat on the incredibly important Rules Committee (the committee that picks the bills up for a vote each day once session gets going in earnest); and I will be returning to my seat on the Judiciary Committee.

I realize that was a lot to take in, but that was just one chamber of our Legislature – now let's turn to the Senate.

Senator Greg Albritton will return once again as the Chairman of the Ways and Means General Fund Committee, a great Chairmanship to have since that committee has sway over the budget for everything in the state of Alabama that isn't education. And I know Senator Albritton will wield that gavel fairly while also making sure that Baldwin County and Coastal Alabama gets the attention and resources it needs and deserves. He'll also serve on the Finance and Tax Education Committee (the committee over the education budget), Judiciary Committee, State Government Affairs Committee, County and Local Government Affairs Committee, Transportation Committee and the Tourism Committee.

Senator Chris Elliott will wield a Chairman’s gavel as well, taking the helm of the newly created County and Local Government Affairs Committee and he’ll be the Vice Chairman of the State Government Affairs Committee – fitting roles for our former county commissioner turned senator who is passionate about finding ways to make government at every level work for the people the way it should. He will also serve on the Judiciary Committee, the Banking Committee and the Tourism Committee.

And our newest Senator to the Baldwin Delegation, though the longest-serving member given her years in office, Senator Vivian Davis-Figures will serve on a number of important committees, including two of them where she will serve as the Ranking Member – the Children and Youth Healthcare Committee and the Economic Development Committee. She will also serve on the Finance and Tax Education Committee, the Judiciary Committee, the Confirmations Committee, the Education Policy Committee and the ever-important Senate Rules Committee.

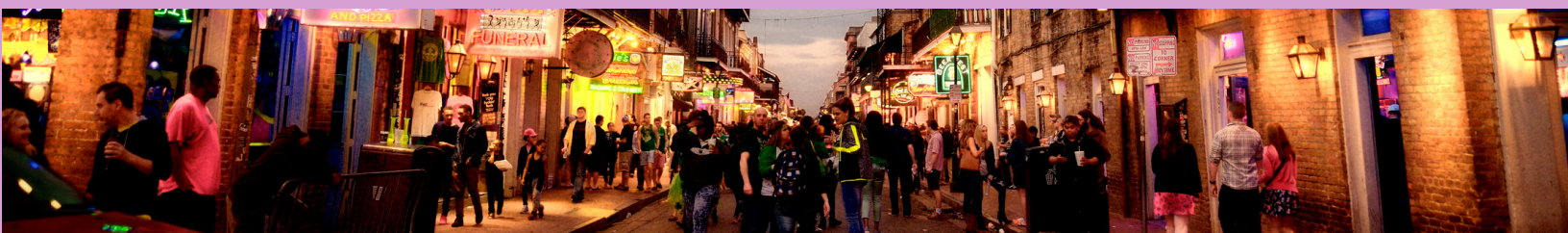
In the "Throws" of Mardi Gras

This time of year we are bombarded with articles about Mardi Gras and its history. We read about magnificent kings, beautiful queens and whimsical Balls. We plow through pictures of fairy tale dresses, jeweled crowns and impressive floats that roll through our area in splendor. These topics are mystical as we imagine the fanfare. All of us are in different stages of life, and often the awe of carnival can wax and wane throughout our personal phases. It can often seem like more of a responsibility than an outlet. I find myself struggling to get through the season as carnival can be sneaky in its approach. With kids that are grown, I admit the fun of floats and Balls has faded this year, but Mardi Gras has strummed many a note in the songs of life for so many of us who call the Gulf Coast home. My less than energetic attitude has taken a turn for the better as I reflect on the rich, living history of Mardi Gras and its impact on my life as well as others. Our families and our unique experiences build a richer history with each parade that rolls.

The silver 1980 Buick station wagon sat in its usual parking space, atop a shell driveway parallel to the riverside. It seemed to be just as excited to leave as me and my four boy cousins were. We anticipated parade times almost as much as we did Christmas mornings. We would run the riverside all day hoping the time would move at lightning speed so we could load the car destined for the sense of wonder in living color, the PARADE! Our sweet, petite, Irish grandmother would answer all of us in the same way as we badgered her about what time we could depart. "Soon," she would cheerfully answer. "Soon" never seemed so long during Mardi Gras but, before we knew it, we were loading up the Buick.

Four rambunctious boys and one girl, all the same age, all 10 and wild. Soon we'd be a living, breathing part of the party. A station wagon full of life; we were on our way! All of us were sharing the backseat, bundled in winter coats with empty garbage bags in our laps. This beautiful memory blooms more precious with each passing year. My grandmother's bravery and grace are still unmatched in my eyes.

Big floats, vibrant lights, horses, bands and dancers aplenty. We just danced. In those times, barricades were really just suggestions. Over the top, we'd jump to clean the streets of shiny coins, necklaces, and moon pies we failed to snatch. As the only girl, the fight was hard. If not for my sweet Mommy Ruth, I'm certain my bag would've never been full with all of those rough boys STEALING ALL THE MOON PIES. A stern lesson in sharing was always an integral part of our carnival experience. The buzz of the parade inevitably ended too soon and we'd trek back to the car for home, for Grandmother's house, to begin operation "Dump & Divide".

I guess it's easy to become tired with the idea of Mardi Gras and the energy it often takes. But in the "throws" of Mardi Gras lies distinctive memories. The remembrance of family and friends are the very breath of its history. Each Merrymaker is the true life of Mardi Gras and with each inhalation, the history grows ever richer. The stories of Mardi Gras decorates front pages of magazines, but the living history lies within our reminiscence.

Let the good times roll forever in our hearts as we continue to be its living breath and wonder. Happy Mardi Gras! And to all the Moms, Dads and Grandparents out there... Thank you for the effort! Thank you for the memories.

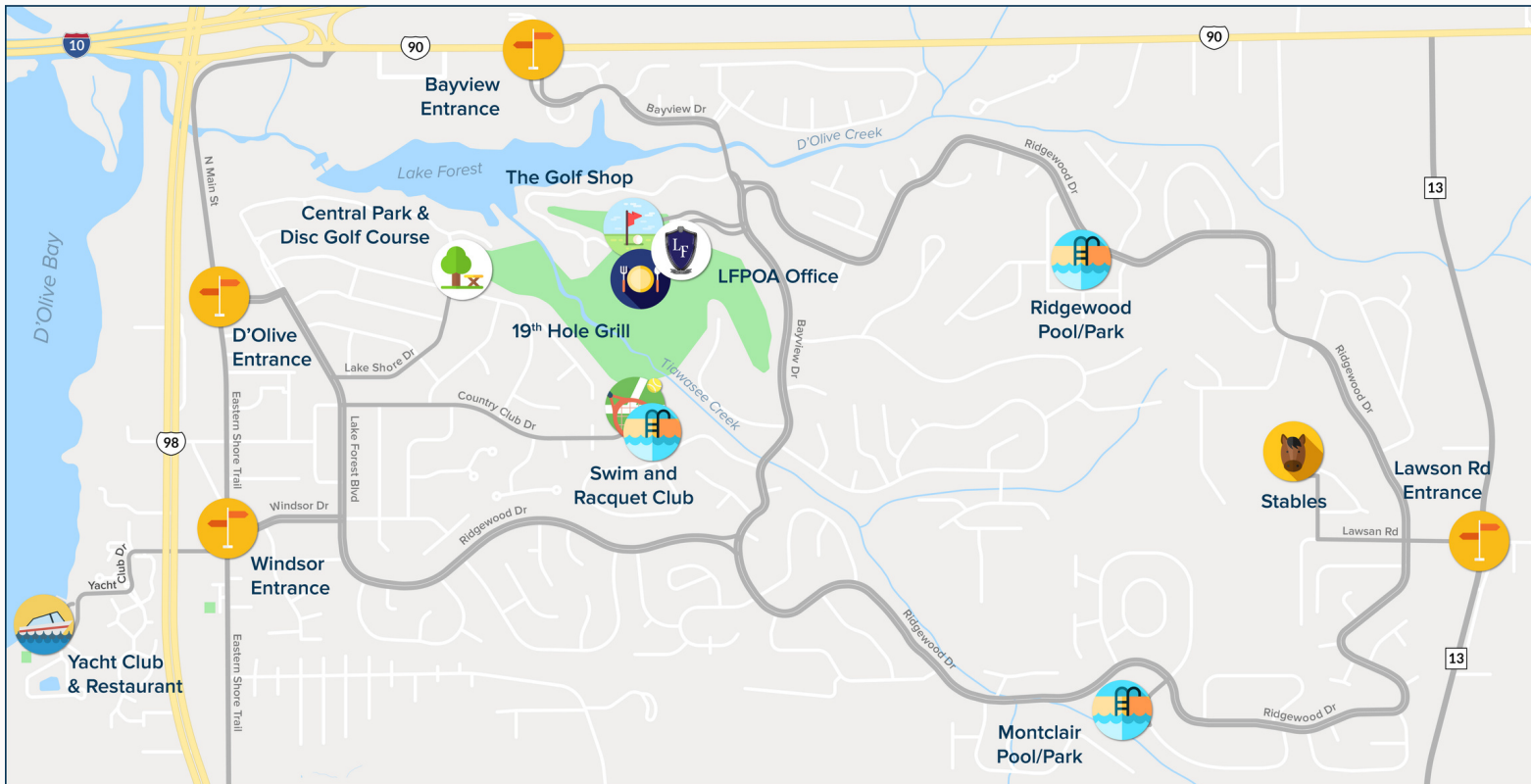
