

Montclair Pool Re-Opens July 1st

Montclair Pool will re-open July 1st at 8:00 a.m. with a security firm in place. Please take note of the following:

- The security firm will be checking for each homeowner to provide a pool card to enter and will be enforcing the stated pool rules.
- Anyone under the age of 16 MUST be accompanied by a parent.
- Each homeowner will be allowed no more than 4 guests per visit.
- All other posted pool rules apply.

Lawsuit and Important Info

As many of you know, the Association filed a lawsuit against certain members and a non-member claiming damage to the LFPOA. In the interest of transparency, and to dispel misstatements and half-truths on social media and other public forums, the Board is providing an explanation of the general nature of the case, the substance of the allegations in the complaint and other filings in the court, and the status of the litigation.

Long–Term Interests of the Members

Only two members applied to run for Board positions last December. This appears to be a consequence of the Defendants' actions, which have undoubtedly cast a dark cloud over the LFPOA. It is completely understandable that many people have reservations about risking being the subject of false, malicious accusations. Hopefully, as the truth is fully exposed, more members will feel comfortable running for Board positions in the future. Contd. on pages 3 and 4

Lawsuit and Important Info contd.

The LFPOA believes that if it chooses to ignore the serious defamatory statements explained below, the defamatory statements will continue. Ultimately, no one will want to serve on the Board, and everyone will suffer.

In addition, the Association contends that the Defendants' actions jeopardized the Association's tax–exempt status under § 501(c)(7) of the IRS code. Any money that goes to Washington D.C. paying taxes is less money to spend on the neighborhood. And a lower net income figure after paying taxes means possibly increasing each member's dues.

The entire situation tends to cast Lake Forest in a negative light. If no one stands up to the false statements, the neighborhood's image will continue to be damaged, which over time, will likely hurt property values and the quality of life in the community. This is an unacceptable risk for the Association.

Looking ahead, LFPOA believes that the lawsuit is in the best long–term interests of the members and future property values.

Nature of the Case

The Association sued the Defendants for defamation and conspiracy to defame. A "Defamatory Statement" is a statement that "tends to harm the reputation" of the Plaintiff and "lowers the community's judgment of [the Plaintiff's] worth or character or discourages others from associating with" the Plaintiff. A false statement can be defamatory if it "tends to impute fraud, dishonesty, or reflect shame" on the Plaintiff. There are two species of defamation – libel (written defamatory statements) and slander (verbal defamatory statements).

Complaint, Motions, and Orders

To briefly summarize some of the allegations, the Association sued the Defendants for alleged defamatory statements, including those made to the Alabama Attorney General ("AG") and the Internal Revenue Service ("IRS"). The Association alleged:

- The Defendants created an illusion of a criminal enterprise in an effort to take over the Board by covertly working together to entice members to sign a petition and believed that the members were more likely to sign the petition if the members believed that the false statements about the Board were actually true.
- The Defendants maliciously accused the Association and its Board of crimes without any factual support to believe a crime had been committed.
- The Defendants advocated for a criminal investigation of the Board and Association.
- The Defendants caused hundreds of letters to be sent to the IRS which, in turn, caused the IRS to perform a threeday audit of the Association, forcing the Association to pay accountants and attorneys to respond to the audit.
- The Association operates under § 501(c)(7) of the IRS code and the Defendants' actions put its tax-exempt status at risk. The Association claims that there would have been serious financial consequences had it lost its § 501(c)(7) status.

It appears that the Defendants disabled their website, <u>www.lakeforeststrong.com</u>, after the lawsuit was filed, but the allegation in paragraph 27 in the complaint states that the "Defendants published a video of an unidentified person purportedly mailing hundreds of letters to the AG and the IRS. The Defendants intentionally misled the community and local media that hundreds of LFPOA members submitted criminal complaints to the criminal agencies."

LFPOA Asked the Defendants for Retractions

The Association claims that it gave the Defendants a fair opportunity to retract their defamatory statements prior to the complaint being filed. As stated in paragraph 37 in the complaint, the Association contacted the Defendants seeking a retraction of the defamatory statements under Alabama law and the Defendants failed to properly retract their defamatory statements.

The Association's position is that the Defendants are responsible for the lawsuit and the legal costs. If the Defendants truly want to reduce further legal costs, they can begin by clearly and unequivocally issuing public retractions consistent with Alabama law. At a minimum, the Defendants can publicly retract and withdraw all verbal and written statements to the AG, IRS, NBC 15, and others that the Association and Board committed any crimes, violated the IRS code or associated regulations, engaged in fraud, or otherwise acted dishonestly or unethically.

Status of the Litigation

As to the status of the litigation, the circuit court dismissed the complaint prior to any discovery taking place. In other words, to be crystal clear, the Defendants have not testified under oath about the allegations. The Defendants have not produced any documents about the allegations, such as their internal communications about the alleged conspiracy to defame the Association and Board. The Defendants have not produced evidence that they believed an actual crime occurred or that the Association was not in compliance with § 501(c)(7) and related regulations. The Association has not been able to send any subpoenas to non-parties for records.

The Association has chosen to appeal the circuit court's order dismissing the case without any discovery. The Association believes this is the best course of action for the long-term interests of the members.

Closing Message

The illegitimate attacks against our Association and its volunteer Board are harmful to the neighborhood. The Association will not remain silent when serious false and malicious defamatory statements are made against the Association. The Association hopes this information provides some clarity on the events surrounding the pending litigation. Let's work together to stop the reckless, uninformed posts on social media and create a better image for Lake Forest.

LFPOA POOL USE MEMBER POLICY AND REGULATIONS

Our pool use policies and regulations are under review by our board and our management team to provide recommended changes that will strive to improve our member experience and allow our community to create and maintain a safe, family friendly environment at our pools.

Currently all our **Pools are posted with signage that include our current pool use r**ules and also indicate that use is "at your own risk".

Recently a Pool Committee was established to review our pool use rules and regulations and to bring forth plausible policy changes. The committee coalesced around a few items that we could implement in the short term and long term. The committee gathered insight from a guest speaker that had served our POA previously as a pool Marshall who provided many insights and observations that were helpful.

Any change to one of our amenity items, including our Pools, should, when implemented strive to "improve the member experience". Changes are being considered as a response to longstanding systemic behavior and misuse complaints from members.

Member review feedback for pool policy changes is requested.

Goal: provide a safe, clean and family friendly environment for our members and their guests to enjoy our pools

Policy changes that could result in additional operating costs would need to be budgeted for in upcoming years. Policy changes attempted to be implemented for this current pool season could result in an unplanned budget expense for this current year.

"member" is defined as:

- 1. a homeowner resident member in "good standing"
- 2. or a "renter" that has been registered with the office and purchased a "non-voting membership"

Note: a "renter" can only purchase a "non - voting membership" if and only if, the actual homeowner of the residence is also a "member in good standing"; which is validated by office staff at time of purchase. The \$100.00 rate for a "non-voting membership" is being re-visited as part of this review and may be subject to a future cost increase.idgewood Pool.



Notes from the Board of Directors contd

POOL POLICY USE PROPOSED CHANGES: (short term and long term)

GATE ENTRY CARD Note; POA member resident owners "in good standing" and "renters" must purchase a POOL **GATE ENTRY PROX CARD** at the POA office.

GATE ENTRY CARD COST:

Original CARD is issued the fee is \$10.00

Renewal CARD is a fee of \$5.00

At the end of each pool season all cards will be "turned off" and deactivated.

Prior to the beginning of each subsequent pool season members will have to visit the office to renew or obtain a CARD. At the time of issue or re-issue members will be required to sign the updated pool policy house and ground rules and a signed copy will be kept on file at the office.

SWIM AT OWN RISK POLICY: our pools are a swim at your own risk.

ADULT MEMBER SWIM HOURS: members age (18) and above "ONLY" from 6 am to 9 am daily all pools will be open for adult swim (note; for Swim and Racket Pool this will be available on days where swim team is not holding morning practice; normally Saturday and Sunday) For swim team schedule please see POA digital newsletter.

FAMILY MEMBER SWIM HOURS: all pools open daily from 10 am to 8 pm. Note; Swim and Racket pool will be available for members outside of hours when the swim team is not holding practice or holding a swim competition event.

POOL GATE ENTRY CARD USE: Members will be required to have in their possession an active GATE CARD upon entry and have their POA member card on hand. Please see the LFPOA office to get an updated membership "SILVER" card.

POOL SUSPENSION OF USE PRIVILEGES: illegal entry, holding gates open for non-member visitors as well as unruly behavior or violation of pool policy and house and grounds could result in suspension of pool privilege.

POA MEMBER GUESTS: members in good standing are allowed up to 4 guests only.

Notes from the Board of Directors contd

PARTIES: pool parties will be permitted at Swim and Racket Pool "ONLY" from 11 am to 2 pm on Sundays. Reservations are required with the office. A deposit will be required. A portion of the deposit will be non refundable. A portion of the deposit will be refundable. Once the scheduled pool party has concluded a Pool Gate Marshall or Management will ensure the area has been cleaned and that no damage may have resulted from the party activity. Parties will no longer be allowed inside the gated pool areas at Montclair Pool or Ridgewood Pool. Pavilions at Montclair and Ridgewood are first come first serve.

PARENTS OR GUARDIANS: are responsible for conduct and oversight of member users under the age of 16. Unruly conduct, misbehavior or vandalism of any type will not be allowed and WILL lead to suspension of pool privileges. Reports to local authorities when appropriate will also be made.

INFANT SWIMWEAR REQUIRED: children and infants not toilet trained must wear specific swim diapers with rubber pants over them to use any pool and kiddie pool at Ridgewood Pool.

POOL GATE "MARSHALLS": will be onsite for all (3) pool locations daily. Gate Marshalls shall monitor entry gates to ensure users have a working ENTRY CARD and active POA Membership Card. GATE Marshall's shall also observe pool conduct and respond appropriately to correct or report activities that are not in keeping with the enjoyment of our members or are unsafe, unruly, or otherwise offensive or could led to damage of property.

POOL GATE MARSHALL TEMP STAFF SUMMER EMPLOYEES: A temporary POA staff team and a supervisor are under consideration to be hired to perform duties ENTRY MARSHALLS during the pool season. Temporary staffing will be sought from personnel that have backgrounds such as with the military, police, fire, safety, teachers, and other similar professional types. Marshalls shall be designated with a name tag or other appropriate clothing.

Marshalls shall ensure the pool deck is cleaned, free of debris and furniture is returned to the designed footprint layout. They report their observations to management as appropriate. The Marshall supervisor may also be recommended and utilized to perform other additional POA duties such assisting with Architectural Enforcement.

LIFEGUARDS: were deemed as not required as our pools are "use at own risk"

CAMERA SYSTEMS: not recommended; have been attempted in the past and determined to not be feasible due to equipment upkeep and monitoring costs

SECURITY GUARDS: not recommended; have been attempted in the past and determined to not be feasible due to cost and due to past poor performance.

In closing the pool use policy changes are being considered to improve our member experience for one of our key amenities.

Proposed Future Pool Rules and Information

Violation of any Rules could lead to suspension or loss of Pool Use Privileges

- SWIM AT YOUR OWN RISK. No lifeguards on duty
- No alcoholic beverages, glass, or food allowed
- No tobacco products-this includes cigarettes, cigars, chewing tobacco, e cigarettes or vaping
- No running, pushing, dunking, rough play, or any type of personal conduct endangering safety of self and others is allowed
- No diving or flips from the side allowed
- No animals, other than certified service animals
- Be courteous to your neighbor. Rude behavior is not allowed
- All bathers must shower before entering pool
- Do not enter the pool if you have an open cut or sores, or if you are ill with diarrhea, nausea, or nasal or ear discharge, or have any contagious condition
- Pools are available to all Member Residents in good standing of LFPOA
- Pools are available to Rental Residents Non Member when the Property Owner is a member in good standing of LFPOA and if an annual amenity card has been purchased.
- Adult Swim Hours are from 6 am to 9 am daily 18 and above only
- At all times, all children under 16 must be under adult supervision
- Swim Diapers are required for all children who are not toilet trained
- Tampering with the Access Gate is not authorized and could lead to loss of pool privileges
- Members MUST use active POOL GATE PROX card to enter and have a POA Membership Card
- Sharing of Pool Gate Entry Cards with the general public, a non-member or with a member that is not in good standing is not allowed and WILL lead to loss of pool privileges
- Members in good standing can invite up to 4 total guests per day
- Damage to any property or grounds could lead to suspension and loss of pool privileges
- Hours of operation are posted.
- Anyone entering the pool or pool area outside of the pool hours of operation is trespassing and will be subject to arrest

Inclement Weather Policy

- All swimmers must exit pool during thunderstorms
- Pool will reopen 30 minutes after lightning strikes cease

Pool Closure

- Immediate closure will occur if there is contamination caused by discharge of fecal matter
- Closure for Safety related concerns can occur when necessary

Pool Events and Parties Policy

- No Pool Parties are allowed inside gated areas of Montclair Pool or Ridgewood Pool
- Pool Parties at our Swim and Racket Pool are allowed by appointment.
- Contact the POA office to schedule a party. A cleaning service fee will also be required.

POOL GATE CARD INFORMATION

Members will need a magnetic "POOL GATE ENTRY" PROX card to access the pools. Get your POOL CARD at the Lake Forest POA office to fill out the request and pay \$10 annual service fee. The POOL CARD can be used for entry to all 3 pools during open hours. A POOL CARD will be issued to members in good standing once the service fee has been collected and a signature card for our Pool Policy Rules and Regulations has been signed.

Our Pools are for the enjoyment of our members. Please enjoy and obey our pool rules for your safety and for the safety of your neighbors.

News from our State House Representative Matt Simpson

In the weeks after a legislative session ends, we are able to see the real-time results of some of the most meaningful bills that were passed during those months in Montgomery.

This year, we were able to put extra protection in place for two groups who are often at great risk in our community -first responders and grandparents facing domestic violence.

First, to safeguard our first responders who find themselves on the frontlines of the fight against the spread of the deadly drug fentanyl, I sponsored a bill that will make



it a crime to knowingly, negligently, or intentionally injure a first responder with a controlled substance such as fentanyl.

Early in the session, we passed my fentanyl trafficking bill which put in place mandatory minimum sentences for those who sell and or distribute this highly deadly drug in our state.

With that, the people of Alabama are now better protected from the dealers of death who are pushing this drug scourge on our streets and on our children.

As we wrote the bill and talked to those on the frontlines of this fight, we realized that it was necessary to also protect the people who are protecting us. That is what Act Number 2023-486 does.

Any injury to a first responder caused by ingestion, inhalation, or contact with the controlled substance will result in a felony charge with the level of felony charge depending on the level of harm caused by the first responders'exposure to the harmful substances. It goes without saying that if one of our heroic law enforcement officers, EMTs, or other first responders is killed through this interaction that it will automatically be raised to a Class A Felony, our highest-level felony.

This is an extra layer of protection for officers, doctors and nurses and other first responders who may be exposed to dangerous drugs every day in their workplace.





News from our State House Representative contd. Matt Simpson

In a similar theme of trying to protect our people across the state, we were also able to layer a blanket of protection on some of the most vulnerable members of our community – grandparents.

The passage of Act Number 2023-494 has placed grandparents on the list of potential victims of domestic violence, along with spouses, children, household members and dating partners.

I watched in shock and horror with many in our community as the tragic deaths of four members of a Daphne family unfolded in February this year.

In that case, a 21-year-old was charged with capital murder in the deaths of his brother, a family friend and his grandparents, at the home in which he lived with them.

At the time, there were no legal means to put a no-contact provision in place to keep the man from returning to the home after he was released on bond for a misdemeanor charge of criminal mischief.

This was something that happened right here in Baldwin County, in the heart of Daphne and my district, and it was something that I could not let just happen and not try to take some legislative action to fix it. No family should ever have to go through the tragedy that happened here.

Now, with the bill's passage, grandparents have the same protections as other victims of domestic violence living in the same household. This will hopefully help prevent future tragedies.

Even with summer in full swing, and the regular session over, the work doesn't end for members of Alabama's House of Representatives and Senate.

Next month, we head into special session to redraw the state's congressional districts. We will also begin drafting legislation and looking at issues to address in the 2024 session.



Golf Pro's Corner

Summer is now in full swing! Here's a tip to enjoy these hot days; go to the beach, go to the pool, go out on a boat but my favorite, riding down a beautiful fairway in a golf cart. If you love golf as I do, prepare for the round and the heat will not be a problem. I first off, recommend riding and not walking in this heat. 
